Alderman Hessenberger presented a plat showing the subdivision of Lot 2 of Mendota Community Hospital 1st Subdivision. Attorney Guilfoyle advised that it should be sent to the Plan Commission since there is an access easement. Alderman Hessenberger stated that a Plan Commission will be organized.

Alderman Fitzpatrick presented and motioned to approve a request from the Mendota Museum and Historical Society to close part of 8th Street for its Annual Railroad Crossing and Heritage Day on June 15th. Alderman Hessenberger seconded the motion.

Next, Alderman Fitzpatrick presented the results from the Bid Opening for the Asbestos Abatement for 704 Illinois Avenue. One bid was received. Alderman Fitzpatrick motioned to approve the bid for \$70,525 from B&B Environmental Contractors. Alderman Hessenberger seconded the motion. The Roll Call Vote: Ayes: Alderpersons Hessenberger, Fitzpatrick, Hochstatter, Holland, Kim, Miller and Peasley. Nays: None. Absent: Alderperson Johnson. Motion carried.

Alderman Holland presented and motioned to approve a request from Graves Hume Public Library for a \$5,000 donation for its summer reading program. Alderman Hochstatter seconded the motion. The Roll Call Vote: Ayes: Alderpersons Hessenberger, Fitzpatrick, Hochstatter, Holland, Kim, Miller and Peasley.

Nays: None. Absent: Alderperson Johnson. Motion carried.

Alderman Miller presented and motioned to approve a contract with Safebuilt Illinois, LLC. They will take over out building permit process. Alderman Holland seconded the motion. The Roll Call Vote: Ayes: Alderpersons Hessenberger, Fitzpatrick, Hochstatter, Holland, Kim, Miller and Peasley. Nays: None. Absent: Alderperson Johnson. Motion carried.

Alderman Miller reminded the council that there will be a License Committee Meeting on April 8th at 5pm in Council Chambers.

Mayor Boelk asked if there was any other business from the aldermen or department heads.

Mayor Boelk inquired if there was any business from the floor. At this time a resident inquired if the city has ever considered allowing golf carts on public right away. Mayor Boelk explained that liability issues have prevented the city from allowing carts. Also, IDOT would never allow them on Rt. 34 or Rt. 51.

Another resident who owns a rental unit inquired why he is getting the nuisance ticket for the rental property instead of the renter. Attorney Guilfoyle said he would look into the situation.

Mayor Boelk entertained a motion to adjourn.

Alderman Kim motioned to adjourn the Regular City Council Meeting of April 1nd, 2024 at 5:49pm. Alderman Miller seconded the motion.
