Attorney Guilfoyle's Business & Correspondence:

Attorney Guilfoyle stated that as of January 1, 2024 non-home rule cities may adopt administrative adjudication hearing systems. This allows the city to pursue local ordinance and code violations. An ordinance adopting the system that includes the due process provisions along with an ordinance updating fines for violations will be on the next agenda. The city intends to hire Jonathan Brandt to be the hearing officer.

<u>Department Head Business & Correspondence:</u> Aldermanic Business & Correspondence:

There was no Department Head or Aldermanic Business. Before Mayor Boelk inquired if there was any business from the floor, he added that the departments did a great job with the back to back snow falls the previous week.

At this time, Rachel Larue, addressed the council. She explained that her daughter, Eden Hollins, and Christopher Oidtman, rented an apartment in Mendota. They initiated the rent online. They paid a security deposit along with first and last month's rent totaling \$2,700. Ms. Larue explained that the photos online made the apartment look much better than the actual apartment was in person. She listed several things that were unsatisfactory, dangerous and/or in violation of Illinois and City Codes. She implored the city to help get the \$2,700 deposit back for the couple and, moreover, inspect all of this landlord's apartments for code violations.

Attorney Guilfoyle explained that the city had just received a report on the situation and the new administrative adjudication system will help with situations like this. The city will have to issue citations on the code violations and adjudicate. He also stated that getting the deposit back is a civil matter and the city can't intervene in the situation.

Mayor Boelk inquired if there were any other comments from the floor. Being none, he entertained a motion to adjourn.

Alderman Kim motioned to adjourn the Regular City Council Meeting of January 15, 2024 at 6:11pm. Alderman Miller seconded the motion.
